On a bright February afternoon, there were wide smiles as Prairie Ridge residents celebrated the installation and operation of Oakwood Village's solar-power project.

The panels are connected to the electric grid to benefit residents, Prairie Ridge, and Earth. The panels are expected to take care of nearly half the power needed to run the common spaces inside Settlers Ridge. Your generous gifts made the project possible. Campus Green Committee chair Lynn Schwantes is excited the project will do more than save Oakwood \$1,500 on its monthly electric bill. "The primary benefit sought by residents and donors who championed the project is reducing airborne carbon emissions. Over 25 years, the panels should keep 100 tons of carbon out of the atmosphere," said Schwantes.
